Your Executors

Your executor(s) will be responsible for collecting in the assets of your estate, paying debts, funeral expenses and taxes, and distributing the balance in accordance with your instructions. They will also become trustees of any parts of your estate retained for beneficiaries who are under age. Your executors should be people you know, trust and whom you believe will be willing and able to accept the responsibility. Your executors should be over 18 years' old and can be your beneficiaries or relatives. Most people choose their spouse as their executor. It is wise to nominate a substitute executor in case your first-choice executor is unable to act as your executor.
